

# MOTORING ABROAD



## I Insurance Documents to take with you

You should take this leaflet with you along with your Policy, your current Schedule (which indicates the extent of cover provided), your Foreign Use Extension and your Certificate of Motor Insurance. If a Green Card has been issued you should take this too. You may be asked to produce these documents on or after entry into the country in which they apply.

## 2 Notes on claims procedure and list of Claims Settling Agents

a) If an accident occurs in one of the countries shown below please notify the nearest Claims Settling Agent immediately. The Agent will render assistance and arrange the handling of the claim. Telephone numbers of the principal offices are provided.

b) Should an accident occur in a country where the Group does not have a Claims Settling Agent, immediate notification should be given to the local Insurer's Bureau (the names and addresses are given on the Green Card which will have been issued.) The Bureau will assist in the handling of any Third Party claims, but you will have to make your own arrangements for essential temporary repairs to your vehicle the cost of which, if insured, will be admissible as a claim under your Policy.

c) Any accident must also be notified to us, RSA, as soon as possible thereafter.

Policyholders involved in accidents must also notify RSA on +(353) 1 290 1000 or Fax us on +(353) 1 290 1001. If your car is damaged to such an extent that you are unable to continue your journey, arrange for its removal to a garage.
